This schedule applies to overseas students who are the primary holders of a sub-class 500 student visa.

The College fees are determined each year by Marist Schools Australia Ltd, detailing tuition, boarding and other costs and may be subject to change. The Tuition Fee for International Students is higher than for Australian students because Australian students receive both Federal and State Government per capita grants. There are also additional administration costs for International Students. It is compulsory for all International Students to contribute to Overseas Student Health Cover (OSHC).

Administration Fee

The administration fee is \$150 (incl. GST) per student and accompanies the Expression of Interest form. This fee is non-refundable.

Compulsory Tuition Fees

Acceptance Fee (partially refundable)

An acceptance fee of \$5,000 is payable at the time of acceptance to secure a place. \$2,500 will be refunded when the student leaves the College provided all financial obligations (including medical bills) have been met, all textbooks have been returned in an acceptable condition to the textbook hire department and any College devices are returned in working order. In the event of Visa refusal, the fee will be considered as part of the refund provisions.

At the time of acceptance, a prepaid tuition and non-tuition fee is required.

Fees are charged in full to accounts at the start of each year. Annual fees are equivalent to two study periods. A semester is one study period and one term is half a study period.

A study period is no more than 24 weeks. Upon enrolment the College will require upfront payment of fee equivalent equal to a semester.

Overseas Student Health Cover (OSCH)

An OSCH payment is required at the time of acceptance of an offer. This is up to \$900 per year payable in a lump sum according to the length of time your son will be attending the College. For example, a student who attends from Years 7 - 12 will be required to pay approximately \$4,000 - \$5,000.

OSHC is arranged through Bupa by the College from the commencement of your son's enrolment. Please note this cover is mandatory and your son would be in breach of his Visa requirements if he was not covered.

Medical expenses are covered under the OSHC. However, a gap payment will be charged to the school fee account.

Optional extras are NOT included in OSHC, however can be purchased separately at an additional cost. Extras cover provides benefits for some additional health services such as dental treatment, physiotherapy and optical appliances. Any out-of-pocket expenses will need to be paid at the time of consultation with the medical provider. For further details, please refer to Bupa OSHC-www.bupa.com.au/health-insurance/oshc

Optional Fees

College Foundation Contribution

	AMOUNT PER YEAR
All Families	\$1,200

This contribution is \$1,200 per family, per year. This contribution is essential to fund the Master Plan for the “Future 2030”. Projects include minor building capital works, refurbishment of Cyprian Pavilion, music area and language classrooms. NB: Some families may be able to assist by offering greater amounts.

Old Boys Life Membership

Applicable to Year 12 only, a one-off fee of \$160 for lifetime membership to the Marist Old Boys community.

Other Voluntary Charges

Music	Ensemble and instrumental tuition offered in a co-curricular program. Billing is separate and bookings made by direct arrangement with department.
Tennis	Membership to Tennis club and training sessions available by arrangement with department.
Swim Club	Swim club and lessons held outside of school hours. Learn to swim and train by direct arrangement. Refer www.mcaswimming.com.au for information and booking.

Other Costs to Consider

- Airfares, toiletries, pocket money
- Additional fees for Private Music Tuition (if participating)
- Additional fees for Boarding Recreation Activities if participating.

- Extra English Tuition – If an Overseas Student requires extra tuition for English, this will be arranged however will be an additional cost to the Parent / Guardian
- Fees for Specialist Medical Appointments (Dental, Physiotherapy etc.) if required.
- OSHC above will help pay toward the costs of most medical and hospital treatment required while studying in Australia. Extras Cover is not included in OSHC however can be purchased separately at an additional cost. Extras Cover provides benefits for some additional health services such as dental treatment, physiotherapy and optical.

Please note that any out-of-pocket expenses will need to be paid to the provider at the time of consultation.

Billing and Payment

The Annual School Fee Statement (issued in January each year) outlines the annual charges: Tuition, Maintenance levy, Technology levy, Student Laptop Program fees, Textbook Levy, Years 11 and 12 QCAA Levy, Boarding Fees and for Year 12 the Old Boys Levy.

Payment Options

When International Student fees are not paid and the account is more than one term overdue, the Parent / Guardian will be required to pay the total outstanding, plus in advance, fees for the next semester.
